Huwa wettaq speċjalizzazzjoni ta' tliet snin wara d-dottorat fit-Teknoloġija u l-Patoloġija tal-Ispeċi tat-Tjur, fniek u Annimali Selvaġġi mill-Università ta' Bari fl-2009. Huwa jaħdem fid-Direttorat tar-Regolamentazzjoni Veterinarja minn Marzu 2006 u għandu esperjenza kbira kemm fis-saħħa tal-annimali kif ukoll fis-saħħa tal-ikel. Fil-fatt Dr Benvenga flimkien mas-Sur Stephen Spiteri, hija l-persuna ta' referenza fi ħdan il-VRD għall-AMR u Saħħa Waħda.

Huwa kiteb diversi artikli dwar l-użu prudenti tal-antibijotiċi u huwa president tat-"Task Force AMR" tal-Istrateġija Nazzjonali kontra r-reżistenza antimikrobika fil-qasam veterinarju. Huwa wieħed mill-ko-awturi ta' din l-istrateġija. Għal dawn l-aħħar 12-il sena kien il-Kap tat-taqsima fi ħdan l-awtorità veterinarja kompetenti Maltija għall-prodotti mediċinali veterinarji.

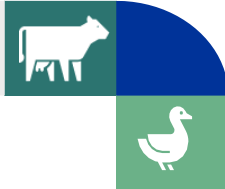

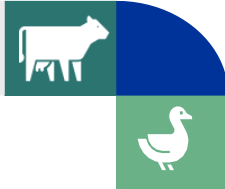
